d. Raider Activity on CHEJU-DO

The attack on CHUNG MU-NI (942-1120) on 05 November, reported in P/R #982, was carried out by an estimated 70 armed and 200 unarmed raiders. One Constabularyman and 2 policemen were killed, 50 raiders were reportedly killed and 9 policemen were wounded. (A-2)

At 051100 November and again at 051900 November an unknown number of raiders attacked SAMSUN-NI (933-1120). No casualties were reported. (CIC Flash Report. A-3)

On 07 November an unknown number of raiders attacked and burned a police box and approximately 7 buildings in SONGI-PO (955-1119). The number of casualties is unknown. (CIC Flash Report. A-2)

b. Raider Activities on CHEJU-DO

At 110300 November raiders attacked the village of SANAM NI (936-1147) and burned an estimated 80 homes. Police report that 80 of the raiders were killed.

The village of CHUCHON NI (963-1155) was attacked by raiders at 110700 November and approximately 30 homes were burned. One policeman was killed. (CIC Flash Report. C-3)

✓ a. Rightist Terrorism On CHEJU-DO

On 09 November members of the NORTHWEST YOUNG MEN'S ASSOCIATION beat to death KIM Toon Hyon, the Chief of General Affairs Section, of CHEJU DO. The NWYMA members responsible for KIM's death stated that he was a known communist but that they had only intended to interrogate him, not to kill him. (CIC P/R #263. A-1)

✓ c. Raider Activities On CHEJU-DO

On 10 November Constabulary units engaged a raider group at WOLLONG BONG (982-1147). Twenty-one raiders were killed and the police captured 12 hand grenades and other miscellaneous equipment. Another Constabulary unit reports that on 10 November they killed 25 raiders at TOPYONG (958-1123). (PMAG Report)

On 11 November approximately 100 homes were reported to have been burned by raiders in SINAM NI (936-1147) and the village of CHOCHON NI (965-1155) was also partially destroyed by fire. (PMAG Report)

✓ g. Constabulary Activity On CHEJU-DO (Delayed Reports)

Constabulary action on 13 November on CHEJU-DO resulted in 115 raiders killed in HAENGAON-NI (979-1157), 37 raiders killed in the vicinity of (937-1133) and 4 raiders killed near ODUNG-NI (954-1146). One of the raiders killed was identified as a constabulary deserter. (CIC Report. C-3)

✓ c. Recent Activities On CHEJU-DO

On 19 November 4 houses were observed burning in the village of S.M TCHEUN DONG (956-1145). A U.S. air observer saw approximately 10 Constabularymen in S.M TCHEUN DONG at the time the village was burning. (CIC Flash Report. B-2)

Fifteen raiders were reportedly killed by Constabularymen at WOLPYONG-NI (957-1146) on 21 November. (Constabulary Report)
