a. Civil Disturbances.

- (2) 154 members of the Ho Han Tai Society were taken into custody at CHEJU (951 - 1151) on the Island of CHEJU-DO. 20 other Koreans armed with clubs were also picked up. 10 members of the Hala Dan Society confined in the upper story of a building there, were being beaten by members of the Ho Han Tai. Further investigation of this Society is being made.

b. Civil Disturbances by Province.

(2) In Cholla-South:

- (a) At CHEJU Airport (951 - 1151), 18 November 45, a Korean woman was shot by a U. S. guard while fleeing from a warehouse with stolen Japanese clothing in her possession. The guard called out "Halt" in Japanese several times in an attempt to stop her before he fired in her direction.

b. Civil Disturbances by Province.

(1) In Cholla-South:

- (a) A Korean, coming out of a warehouse containing Japanese supplies, was killed by a U. S. guard on 15 Dec 45, at CHEJU-DO. The Korean had refused to halt when challenged by the guard.
- ✓ (b) In investigated the reported riot on CHEJU-DO, 12 Dec 45, U. S. troops accidentally killed one Korean. Disobeying an order given in Korean to stand fast, the crowd fled and the one Korean was killed when U. S. troops fired over the heads of the crowd.

b. Civil Disturbances by Province.

In Cholla-South:

- ✓ Investigation of the killing of a Korean on CHEJU-DO, 12 Dec 45, (para 3b (1) (b), G-2 Report #56, 15 Dec 45), disclosed the following:

A detachment from the 59th Military Government Company accompanied civil police to CHUNGJUN-RI (not on map), to quell the reported riot. On arrival it was found that a group of townspeople had beaten the Mayor and were in possession of the City Hall. On sight of U. S. troops the rioters attempted to flee. When they refused to halt as ordered (Korean language was used), the detachment Commander ordered his men to fire over their heads. One shot was low, hitting and killing KIM, Heng.

Cause of the disorder was determined to be personal dislikes of the Mayor. No political parties were involved.
