a. General Conditions.

- (4) The Btry "B", 51st FA Bn platoon on CHEJU Island reports that the 330 local policemen have been reinforced by 100 additional police from the mainland. 150 of these 430 policemen are stationed in the city of CHEJU (951 - 1151). A constabulary company of six officers and 110 enlisted men is stationed at MOSULPO (524 - 1117), but, since they lack transportation, they cannot support the police at CHEJU.

b. Civil Disturbances by Province.

✓ Cholla-South:

- (1) In CHEJU City (951 - 1151) at 1000, 1 March 47, there was an unauthorized parade and meeting of about 1,000 people. The mob marched on the police buildings and attacked the police at 1445. The police fired into the mob. Four civilians were killed and an unknown number was injured; one of the wounded rioters died later. One policeman was slightly injured; no American casualties. U.S. troops assisted in dispersing the crowd. The Chief of Police of CHEJU City made a request to National Police Hq for 100 additional police from KOKPO (938 - 1037); they were dispatched by boat at 1700, 1 March 47. The situation is quiet but tense.

- (2) CHEJU (951 - 1151) MG employees, including a few of the Police Department, went on strike on 13 March. The strike is reported to have been engineered by the "South Korea Labor Party" (new name for

the Communist Party). No disturbances reported. MG plans to dispatch 125 policemen from CHOLLA-SOUTH Province and 100 policemen from CHOLLA-NORTH Province on the morning of 14 March from the port of MOKPO. The platoon from the 51st FA Bn, stationed on CHEJU reported that fires of unknown origin are started approximately every other night on CHEJU air-strip; the arsonists have not been apprehended.

b. Civil Disturbances by Province.

Cholla-South:

CHEJU (991 - 1151): A general strike is in progress on CHEJU Island. The management and labor of all transportation agencies including a large percentage of the shipping, are on strike. This applies also to all factories, both Korean owned and those supervised by MG. The teachers and pupils of all schools are also on strike. 75% of the Korean MG employees are on strike. Although many and varied demands are being made by the striking elements, the basic reason for the strike appears to be a hatred for the police because of police actions during the 1 March riot; this hatred has been engendered by recent agitation of the populace by the "South Korean Labor Party" (Communist). No violence had been reported as of the end of this period.
