(3) Cholla-South:

- (a) CHEJU (951 - 1151) - The strikes still continue but are slowly disintegrating. All Provincial Government employees have returned to work. Approximately 90% of the industrial and the commercial employees have also returned to work. Public transportation is now operating at about 50% normal. No civil disturbances reported.

- (b) CHEJU (951 - 1151) - Additional data on the recent strike (Reference G-2 Reports #511, 13 March 47, through #513, 15 March 47, #515, 17 March 47, through #517, 19 March 47): In CHEJU City all MG employees except the Police and the Korean Governor joined the strikers. The police, who were sent from the mainland, operated the CHEJU City power plant. A MG Major went to MOSULPO (935 - 1117) during the strike and found that the entire police department had joined the strikers. Posters denounced U. S. Imperialism were found throughout the City of MOSULPO. The Korean Constabulary, stationed near MOSULPO, did not join the strike.

(EXTRACT: USAFIK G-2 Periodic Report #486, 22 March 1947):

"CHEJU-DO (980 - 1130) - 19 March 1947 - A CIC report dated 21 March states that information has been received from the National Police that 1,000 people approached CHUNG MUN jail on the Northeast coast of CHEJU Island and demanded the release of a prisoner. The people were armed with clubs and rocks. When the crowd began throwing rocks and attempted to rush the jail the police fired, wounding four people. The crowd dispersed following the shooting."

b. Illegal Activity of a Subversive Nature.

- (1) Extract KWANGJU CIC Report #539, 22 March 1947: "At 0915, 22 March 47, an illegal meeting of about 150 Military Government officials was held in the rear of the Provincial Capitol grounds. The meeting lasted about 20 minutes and broke up upon the appearance of the MG Chief of Civil Affairs Officer (Military Governor). Although it appeared as if the meeting was instigated by a few disgruntled MG employees, agitators could be seen moving through the crowd and probably the real leaders back of the meeting were not among the si-
